### CRHA Redevelopment Coordinator Monthly Report Prepared by Brandon Collins on April 12, 2024

January to March resident engagement at a glance:

In the coming month a lot will happen, we anticipate completing Crescent Halls apartments fully, relocation process for Sixth Street, demolition of S. 1<sup>st</sup> Street, preparing for Westhaven Redevelopment kick off, and the start of HVAC and electrical upgrades for the "Parallel Track"

- II. Site Updates
  - A. Crescent Halls: Breeden Construction is steadily moving towards completion of the 2<sup>nd</sup> Floor and passing important inspections. Minor punch list items in other portions of the building are being addressed quickly. Plumbing issues are being resolved to ready the tub rooms, and exterior punch items are being remedied. Some site work is still needed to repair or address work incorrectly done by the previous contractor. Gazebo, Bike Racks, Planters, grading, and the traffic gate will be able to proceed after or during site work completion. Residents Continue to meet monthly for updates and guidance.
  - B. South First Street Phase 2: Southern Environmental is carrying out abatement/material and will complete this portion of the work in the next 2 weeks so that full demolition of the site can begin. Contract Pricing and finalization is nearing completion. Residents have resumed a regular meeting schedule and have recruited a few new planners for the group. Residents will be working towards programming and services for Phase 1 and 2, finalizing design issues and getting updates.
  - C. Sixth Street: HUD approved the demo/dipso application in early April after much prodding and some support from Sen Kaine's office. This means that relocation can proceed and demolition of the 707 building can begin in 90 days. We are hoping for a speedy response from HUD in order to issue relocation notices and set a clear construction start date for Building A however we have not yet received word. Contract Pricing and finalization is nearing completion. Resident Planners have resumed outside meetings to guide construction, get updates, tweak Building A plans, and begin detailed work on Phase 2.
  - D. Westhaven: Arnold Design Studio and partners have been selected to lead the Master Planning effort at Westhaven. While the team is being on-boarded, residents are doubling down on some key redevelopment basics, learning about the Master Planning process, assisting in the effort to identify programming and services priorities, and planning for the Master Planning kick off.
  - E. Parallel Track: The CFP and 5 Year Action Plan was approved by the Board at the last meeting. Residents are looking forward to the HVAC/Electrical upgrades slated to begin within the next month or two. Residents will be learing/guiding the HVAC process, finalizing kitchen appliance selection, and beginning to evaluate upstairs bathroom renovations.
